**Terms and conditions for the Guest Faculty/Instructor to be engaged on contract basis**

1. Remuneration: Rs. 1000 per class up to the maximum ceiling of Rs. 50000/- in a month.
2. Period of engagement: The period of engagement under this offer shall be valid for 03 months.
3. This engagement is made purely on temporary and contractual basis for fixed period.
4. Selected candidate is not entitled to any other benefit such as Confirmation, LTC, Medical reimbursement etc. which is admissible to the regular employees of the University.
5. There will have no claim for regularization/seniority on the basis of this engagement.
6. The University reserves the right to terminate this engagement any time even before the stipulated time, without assigning any reason.
7. Selected candidate will have to perform the teaching and other duties as assigned by the Director of the Campus/Head of the Department which is subject to review time to time.
8. Selected candidate will be required to engage classes/ duties in the Campuses as per its requirement in accordance with the directive of the University/directions of Director of the Campus.
9. During the tenure of the above engagement, the Guest Faculty/Instructor will not engage himself/herself in any other assignments or gainful employment.

**Educational Qualification:**

**GUEST FACULTY (ASSISTANT PROFESSOR GRADE) (POLITICAL SCIENCE)**

i. A Master's degree with 55% marks (or an equivalent grade in point scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University or an equivalent degree from an accredited foreign university.

ii. The candidate must have cleared the National Eligibility Test (NET) in concerned Discipline, conducted by the UGC or the CSIR, or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions :-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.
