- 2. The vehicle mentioned in the serial number one i.e. Maruti Suzuki Dezire is required monthly basis for the official use of Director, Central Sanskrit University, Ekalavya Campus and other remaining listed above vehicles are required as per need of the campus on daily basis.
- 3. The hiring charge of vehicle should not exceed the ceiling limit guided by the DFRT-2019 of the Finance Department, Government of Tripura.
- 4. The bidder shall be submit their bid in two sealed envelopes one is Technical bid and other is Financial bid as per instruction as under.
 - Technical Bid: The envelope of "Technical Bid" should be properly sealed and subscripted in bold letters on the top as "TECHNICAL BID OF VEHICLE" and in the said envelop the bidder must submit xerox copies of upto date certificates in respect of Pollution, Insurance, Road Tax and Fitness Certificates, PAN Card, of the firm/agency/bidder, Copy of GST Registration, Original Copy of the Earnest Money Deposit.



- Financial Bid:- The envelop of the "Financial Bid" should also be properly sealed and subscripted in bold letters on the top as "FINANCIAL BID OF TENDER OF VEHICLE in ii. which the bidders shall quote their rates both in figures and words for the items as mentioned in col.no. 3 and 4 of the above table.
- 5. Both the envelopes (Technical and Financial bids) should be put in one sealed big envelop which should be properly sealed and subscribed in bold letter on the top as "TENDER OF VEHICLE" and shall be dropped in the tender box which will be kept available in the Accounts office premises from the date of issue of the tender notice and up to the last date of submission of tender i.e. 13./11/.2023 up to 12.00hours.
- 6. The tender box will be kept available for dropping the tender during office hours (10.00AM to 5.00PM) on working day only.
- 7. The technical bid will be opened at first on 13.11.2023 at 12.00 noon if possible in the office of the Director, Central Sanskrit University, Ekalavya Campus. The Financial bid will be opened only for the bidder(s) who will be found eligible/qualified in the Technical Bid.
- 8. Interested bidders or their authorized representatives may remain present during opening the Tender.
- 9. No tender will be received or accepted after the date and time as mentioned above.
- 10. The vehicle should be provided with driver having self-driving license.
- 11. The vehicle should be provided with KM cable in operating condition always.
- 12. The vehicle will have to run in all weather and on all kind of road like plain and hilly area.
- 13. The vehicle should not be older than the date of manufacture on 2021.
- 14. A log book is to be maintained indicating journey, location KM run etc. will be recorded & maintained by the driver of the vehicle and to be signed by the travelling person after completion of
- 15. Bill in the triplicate along with the copy of Log Book and work order should be submitted for payment after the completion of every month.
- 16. Payment of all Govt. taxes, fitness certificate, road permit, insurance, etc of the vehicle including purchase of fuel, lubricants, tires, tubes, and time to time repairing etc shall be responsibility of the owner/ firm/agency. The payment of monthly salary/wages of the driver shall have to be borne by the owner/firm/agency.
- 17. In case the vehicle needs any maintenance, the owner /firm! agency should place alternative vehicle of equal model/manufacturer until it gets fit for journey.
- 18. The driver should report to the office within 9.15AM every day and shall continue his duties with the vehicle until the day's duty is over. In case of any emergency of office work, the driver may be asked to report early in the mornings as and when required. The driver may also be asked to perform duty with the vehicle on Sundays and other Govt. Holidays on emergency as and when required.
- 19. The vehicle may be released after giving 01(one) month notice without assigning any reason.
- 20. The detention charge and rate per kilometer charge will be considered as per the quotation submitted by the bidders and the lowest rate will be accepted subjects to the aforesaid ceiling limits.
- 21. No correspondence shall be entertained with any applicant after opening of tender, except with the successful bidder.



- 22. If the vehicle remains off on the road for more than 2 hours, the concerned agency/owner have to arrange another alternative vehicle by his/her own cost and failing which Director, Central Sanskrit University, Ekalavya Campus may arrange another vehicle at the cost of the agency/owner of contracted vehicle.
- 23. Sundays, holidays and not performing the journey shall not be taken into consideration for payment
