Scope of Work and General Instruction for Tenderers

- 1. Central Sanskrit University, Ekalavya Campus intends to engage a reputed, well established and financially sound Manpower Supply Agency, registered with appropriate authorities for providing manpower to perform jobs assigned to outsourced staff.
- 2. This Institute has tentative (initial) requirement of approximately 30 staff in categories like- supervisory level, highly skilled, skilled, semi-skilled and unskilled. Salary of outsourced staff shall be decided by CSU, ELC @Central Govt. rates based on their educational qualification, experience and required skill sets. However, the number of staff may increase/ decrease based on Institute's requirements.
- 3. The contract is likely to commence from 01-11-2022 and would continue for a period of 1 year. The period of the contract may be extended for similar or lesser period after the successful / satisfactory completion of initial contract and based on the manpower requirement at that time. The contract may also be curtailed / terminated before the contract period owing to deficiency in service or substandard quality of the manpower deployed by the selected Firm/Agency. This office, however, reserves right to terminate the contract without assigning any reason thereof at any time after giving two-month notice to the selected service providing Firm/ Agency.

PART- III TECHNICAL SPECIFICATIONS

- 1. The Service Provider should fulfill the following technical specifications:

PART-IV

GENERALS TERMS AND CONDITIONS

- 1. Payment Terms: The standard terms of payment are within 30 days from the date of submission of bills in triplicate along with work completion certificate certified by the competent authority in CSU, ELC. The contractor shall raise the bill only after releasing the salary of outsourced staff and thereafter reimbursement shall be made through Cheque/ RTGS. The payment shall be made on conclusion of the calendar month only based on duties performed by each person during the month and payments made to staff towards their salaries, PF, ESI and other statutory obligations.
- 2. Payment of salary by Service Provider: The Service Provider shall ensure that the salary to the persons so employed is made by 7th day of the succeeding month through ONLY bank transfer.
- 3. The Employee Provident Fund (EPF) and Employee State Insurance (ESI) contribution in respect of all employees shall be reimbursable basis on production of challan/receipt copy along with the monthly bill.
- 4. The salaries of all outsourced staff have been linked to Central Wage Rates, protecting their current salary. If there is any upward, revision in the minimum wages during the contract period occurred, contractor shall make the payments accordingly, and CSU, ELC will reimburse the differential amount towards minimum pay revision of workers time to time.
- 5. CSU, ELC's rules of Leave, Overtime and Outstation Travel Payment shall be applicable on all outsourced manpower and contractor shall raise the bill accordingly in their monthly bill. However, CSU, ELC reserves right to bring amendment in these rules without any prior notification at any point of time.
- 6. Income Tax: The Income Tax/TDS and other statutory deductions, as applicable will be deducted from the payment. Tax deduction certificate will be issued to the Service Provider by CSU, ELC.
- 7. Termination of the Contract: In case of any material violation of any of the terms and conditions by the Service Provider, the CSU, ELC reserves its right to unilaterally terminate the contract. In case of any dispute, the decision of the Competent Authority in the CSU, ELC will be final and binding.

- 8. Statutory obligations: The Service Provider is required to deposit a valid license from the competent licensing authority under the provisions of Contract Labour (Regulation and Abolition) Act 1970 and Contract Labour (Regulation and Abolition) Central Rules, 1971 within 30 days of the date of the award of the contract. If the Service Provider fails to provide license for any reason whatsoever or fails to deposit the license within the stipulated period of 30 days, the contract shall automatically stand terminated and earnest money/ performance security deposited by the service provider will stand forfeited unless condoned by CSU, ELC. The Institute shall be at liberty to recover losses, if any, from the Service Provider.
- 9. The Service Provider shall be obliged and solely responsible to comply with all statutory requirements in respect of the manpower engaged by him and the Institute shall not be a party to any dispute arising out of such deployment by the contractor.
- 10. Security Considerations: The persons deployed by the Agency should not have any Police record/criminal cases against them. The agency should make adequate enquiries about the character and antecedents of the persons whom they are recommending. Any person deployed by the service provider should not indulge in act of misconduct or otherwise or later if any. Service will be ceased with immediate effect, if any employee deployed by the service provider found in such activities.
- 11. Place of Duty, Working Hours and Punctuality: The Institute is located at Central Sanskrit University, Vill-Sipaipara, Po-Lembucherra, Agartala, West Tripura. The personnel so deployed shall have to report for duty at the above place or any new location. No extra liability on this account will be borne by CSU, ELC.
- 12. The working hours of the Institute will be from 09.00 a.m. to 6.00 p.m. The personnel deployed shall work from 09.00 A.M. to 06.00 P.M. on all working days (Including 1/2-hour lunch break). Only the Security personnel duty will be 24 hours in rotation-wise.
- 13. The manpower so deployed shall have to adhere to the punctuality strictly. Late arrivals, early departures and short leaves shall not be permitted.
- 14. If need arises, the outsource staff shall have to sit late or come early or attend the Office even on Sunday/Gazetted Holidays (as per work requirements). For working in the office, beyond office hours for period exceeding one hour or on Sunday/Gazetted Holidays, payment will be on hourly basis as per minimum wage rates.
- 15. The responsibility of statutory/compulsory deductions like EPF/Income Tax/GST etc. will be of the service provider. The Institute shall make no extra payment.
- 16. The Service Provider will provide to the CSU, ELC a list of all personnel so deployed with their permanent and present address along with their latest photographs and Aadhar copies.

- 17. The copies of appointment letter issued to the personnel deployed in Institute shall be provided to the CSU, ELC.
- 18. The Service Provider shall provide pay slip duly indicating details of pay of all concerned deduction thereon should be given to each employee while disbursement of pay.
- 19 The Service Provider shall be responsible for all acts of commission and omission on the part of the manpower engaged for the purpose. The CSU, ELC shall not be responsible in any manner, whatsoever, in matters of injury/death/health issue etc. of the Service Provider's employees performing duties under the contract.
- 20 It shall be responsibility of the Service Provider to issue the employment card/ photo identity card to the workers as per the prescribed format and maintain the muster roll, the wage register and other registers as provided in the Contract Labour (Regulation & Abolition) Act. Service Provider will ensure that all its employees invariably wear ID card during office hours.
- 21 The Service Provider shall arrange such facilities like EPF and ESI as provided in the Contract Labour (Regulation and Abolition) Act, 1970 for the welfare and health of the workers deployed with the Institute.
- 22 The Institute shall not be liable for any loss, damage, theft, burglary or robbery of any personal belongings, equipments or vehicles of the personnel of the Service Provider.
- 23 The Service Provider shall be responsible for any damages done to the property of the Institute by the personnel so employed. The CSU, ELC will be free to recover it from the security deposit given by Service Provider or from any other dues.
- The Service Provider's personnel working in the CSU, ELC should be polite, cordial, positive and efficient while handling the assigned work and their actions should promote good will and enhance the image of the Institute. The Service Provider shall be responsible for any act of indiscipline on the part of persons deployed by him.
- 25 The Service Provider shall ensure proper conduct of his persons in the office premises, and enforce prohibition of consumption of alcoholic drinks, paan, smoking, loitering without work etc.
- The Service Provider's personnel shall not divulge or disclose to any person, any details of office, operational process, technical know-how, security arrangements and administrative/ organizational matters as all are of confidential/secret nature.

Undertaking from the person to this effect will be required to be submitted by the Service Provider to this office.
- 28 The Service Provider shall be contactable at all times and message sent by email/ Fax/ Special Messenger from the Institute to the Service Provider shall be acknowledged immediately on receipt on the same day.
- 29 The Agency shall provide three (3) sets of Very Good quality uniform with a pair of shoes with Photo Identity Cards to its personnel deployed at CSU, ELC at its own cost and ensure that these cards are to be constantly displayed, maintained in good condition and their loss should be reported immediately.
- 30 The Service Provider shall depute one coordinator, who would be responsible for immediate interaction with the CSU, ELC so that optimal services of the persons deployed by the Service Provider could be availed without any disruption. He/she will be responsible to maintain Leave Record/ Service Record/ Wages/Overtime payments and other registers and works as required under various labour laws.
- 31 The Service Provider shall not assign, transfer, pledge or sub-contract the performance or service without the prior written consent of the CSU, ELC.
- Arbitration: Any dispute/difference arising out of or relating to this agreement including interpretation of its terms will be resolved through joint discussions of the concerned parties. However, if disputes are not resolved by joint discussions, then the matter will be referred to arbitration as per the provisions of Arbitration Act, 1940, where the Director, CSU, ELC or his/her nominee will be the Sole Arbitrator.
- 33 The dispute between the parties shall be resolved through Arbitration by Arbitrator appointed by Director, CSU, ELC, Agartala within the jurisdiction of Agartala Court.
- 34 CSU, ELC reserves right to terminate the contract at any point of time by serving two months notice to the Service Provider.
- 35 Essentially, the Service Provider shall be the "Employer" within the meaning of different Labour Legislations in respect of manpower so employed and deployed in the CSU, ELC. The persons deployed by the Service Provider at CSU, ELC shall not have claims of any Employer and Employee relationship nor have any Director and agent relationship with or against CSU, Ekalavya Campus, Agartala.
- 36 The person deployed by the Service Provider shall not have any claim or entitled to pay, benefits and other facilities during the currency or after the expiry of the contract.

FRAUD AND CORRUPT PRACTICES

- 38 The tenderer applicant and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Bidding Process.
- Notwithstanding anything to the contrary contained herein, CSU, ELC may reject a tender without being liable in any manner whatsoever to the tenderer, if it determines that the tenderer has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice in the Bidding Process.
- 40 Without prejudice to the rights of the CSU, ELC under clause mentioned hereinabove, if, a tenderer is found by the CSU, ELC to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Bidding Process, such tenderer shall not be eligible to participate in any tender floated by CSU, ELC.

LEGAL

- The Service Provider shall be responsible for compliance of all statutory provisions relating to Minimum wages, Provident Fund, and Employees State Insurance etc. in respect of the persons deployed by it in CSU, ELC. The Service Provider shall furnish a certificate in each month that all statutory requirements have been fulfilled along with the bills for payment.
- 42 In case the CSU, ELC is being made party to any litigation by the employee of the manpower agency for any reason whatsoever, the manpower agency shall bear/indemnify any cost incurred by the CSU, ELC.
